### ICEP Legislative Update: Protecting **Emergency Physicians and Patients**

"I am not bound to win, but I am bound to be true. I am not bound to succeed, but I am bound to live by the light that I have. I must stand with anybody that stands right and stand with him while

he is right, and part with him when he goes wrong." – Abraham Lincoln

These words have long been attributed to Abraham Lincoln, although actual documentation is somewhat suspect. Still, they are stirring to the soul of politics and were used by President Obama before the passage of the Affordable Care Act so please grant me some leeway in my using them here as we embark upon another very busy legislative season. This year ICEP is approaching the legislative calendar using a threeprong approach of active legislation, defending the principles of our specialty against old and new threats, and spirited engagement with Illinois regulatory bodies. Our key partners in this endeavor are the public strategy firm MERCURY LLC, and the Illinois State Medical Society.

Legislatively, we have worked with Illinois senator Laura Fine of the IL 104th and Illinois House of Representative Natalie Manley of the IL 104th district to introduce Senate bill 2294 and House Bill 3435 respectively. Both bills will strengthen existing laws to protect emergency physicians, nurses, and emergency department workers from violence or threats of violence. Specifically, the bills will require hospitals to meet threshold standards for preparing and preventing potential acts of violence including provisions for security and facility upgrades. More importantly, they will require hospitals to document and report violent incidents annually to the Illlinois Department of Public Health (IDPH) detailing occurrences, injuries, and security plan updates. The importance of this legislation became abundantly clear with the stabbing of an emergency physician in the chest while on duty at Provident Hospital on February 17, 2025. See ICEP's statement on the Provident incident on page 5 of this EPIC.

To date, hospitals do not report such incidents, so it is challenging to have discussions with legislators or the public because the scope of the problem has gone unreported for so long. H. James Harrington, a chief executive once wrote "If you can't measure something, you can't understand it. If you can't un-

derstand it, you can't control it. If you can't control it, you can't improve it. This maxim is taught in every health and safety quality course. The problem with violence against health care workers is that we have not even begun to measure it. These bills will change this while beginning the process of bringing real safety to not only ED workers but also to our patients.

**Defensively**, we will be looking for the reintroduction of prior sessions' bills as well as the introduction of new ones that threaten our specialty. Two that re-emerged are SB 271 introduced by senator Javier Cervantes and HB 2468 by Representative Barbara Hernandez. Both bills will effectively remove the name Assistant from the word Physician Assistant by allowing such practitioners to obtain their own medical licenses and to practice independently of Physicians. This represents a grave threat to the citizens of Illinois because of its lowering health care standards. Increasing patient access to health care is to improve access to physician led care, not by lowering standards. This situation is analogous to the desire to lower prices for airfares by allowing pilots who can fly a Cessna to suddenly be allowed to fly commercial jumbo jets without additional training or licensure. Lowering safety standards always results in increased costs rather than

lowering them. Lowering costs are always best addressed through improved quality and efficiency.

We are actively talking to IDPH regarding proposed changes to the Emergency, Medical, Treatment and Labor (EMTALA) law to make sure they remain fair to emergency physicians and always require the presence of a physician in comprehensive and basic emergency departments.

This legislative season we need you and your support! Our legislators always want to know how many members we represent so if you have friends, you are not ACEP members, please ask them to join now! Opposing forces have large numbers and if we do not join, our spe-

cialty, our colleagues, and our patients are at risk.

I encourage you to join us for ICEP's Advocacy Day April 10th, 2025, in Springfield, IL and ACEP's Leadership and Advocacy Day in Washington DC on April 27-April 29th. Both conferences are not only great personal investments in yourself but will bring you a sense of engagement and participation that physicians need more than ever. [CHICAGO, IL] — A terrible episode of workplace violence took place yesterday in the Provident Hospital emergency department on the Southside of Chicago when a patient attacked two healthcare workers with a knife. One of these workers was an emergency physician who was stabbed in the chest and was transported to the University of Chicago trauma center a few miles away.

The Illinois College of Emergency Physicians (ICEP) wishes to extend its thoughts and prayers for the speedy recovery of these two workers.

This incident is yet another example of the continued rise in violence against healthcare workers in the emergency department. Healthcare providers put themselves in harm's way every day to serve and protect the public, and deserve better facilities, equipment, and training to mitigate such threats.

ICEP has collaborated with Illinois State Senator Laura Fine of the IL 104<sup>th</sup> district and Illinois Representative Natalie Manley of the IL 104<sup>th</sup> district to introduce Senate bill 2294 and House Bill 3435 respectively. Both bills will strengthen existing laws to protect emergency physicians, nurses, and emergency department workers from violence or threats of violence while at work. Specifically, the bills will require hospitals to meet threshold standards for preparing and preventing potential acts of violence including provisions for security and facility upgrades. More importantly, they will require hospitals to document and report violent incidents annually to the Illinois Department of Health detailing occurrences, injuries, and security plan updates. Because hospitals are not currently required to report such incidents, it is challenging to have discussions with legislators or the public because the scope of the problem has gone unreported for so long.

We humbly ask the public to remember the dedication of these two healthcare workers to their profession and to keep them in their thoughts. We also ask the public to write or call their state legislators to support this important legislation.



Original research that has not been published in peer-reviewed form. Adherence to Annals of Emergency Medicine format: study objectives, methods, results, and conclusion. Abstracts are limited to 3500 characters not including spaces. Tables or figures must be black and white with at least 300 dpi. Authors should not be identifiable via the title or body of the abstract.



## **REVIEW PROCESS**

Abstracts will be peer-reviewed in a blinded manner. Review criteria focus on the validity, generalizability, and novelty of the findings, and the projected magnitude of impact on the quintuple aim.

# **ACEP Navigating Immigration Enforcement in the Emergency Department**

NOTE: The information in this document is general guidance only and does not constitute legal advice. State laws and facility policies can vary greatly-consult your hospital's administration or general counsel for more specific guidance.

#### **Overview:**

In 2021, the director of the U.S. Immigration and Customs Enforcement (ICE) issued an internal memo directing ICE officers to generally avoid conducting enforcement activities (such as arrests, interviews, searches, and surveillance) at protected areas, including hospitals, churches, and schools. Housed under the Department of Homeland Security (DHS), ICE is the federal agency responsible for identifying and eliminating border, economic, transportation, and infrastructure security vulnerabilities. On January 20, 2025, this internal ICE policy was rescinded by DHS. Therefore, ICE officers are no longer discouraged from conducting enforcement activities in these areas, and the change could potentially lead to increased enforcement activities in these settings.

#### What Does This Mean for You?

Although ICE officers are no longer discouraged from conducting enforcement activities at protected areas including hospitals, how a hospital responds to ICE should be no different today than it was previously. Hospitals should ensure they have and follow policies and procedures for interacting with ICE officials.

ICE officials may enter a public area of a health-care facility without a warrant or the facility's consent and may question any person present. Anyone questioned under these circumstances has a right to remain silent. To enter a private area (an area not open to the public) of a health care facility or ED, enforcement officers must have either a warrant or consent from an authorized hospital staff person.

Health care providers have no affirmative legal obligation under federal law to inquire into or report to federal immigration authorities on a patient's immigration status\*. Federal health information privacy laws including HIPAA prohibit hospitals, physicians, and other health care providers from disclosing patient information to ICE officers unless:

- The patient signs a legally compliant "authorization for the release of information" form.
- The officer provides a valid subpoena, subpoena duces tecum, search warrant lawfully issued to ICE, or court order (for medical information requests).
- The officer provides a valid judicial warrant signed by a United States District Court judge or magistrate (for physical access requests).
- Another law (including state law) may require disclosure.

If ICE officers present themselves:


- Remain calm and composed. Call your hospital counsel or other designated authorized staff, with whom you have prepared for any such interactions.
- The appropriate, trained person should be the only interface with ICE. The hospital should have at least several people trained to do this as you cannot predict when they will show up and who will be on premises that day.
- Be polite, but be clear that you understand the law, the organization is compliant, and ask them if they have a warrant.

- If they do not have a warrant, keep them in the public space. While the officers have a right to question any person present, anyone questioned has a right to remain silent.
- Do not confirm nor deny the presence of a particular patient to the ICE officer.
- Be mindful of what is in "plain view", as officers have the right to look at anything that is in "plain view" in a public area. This can include papers or files visible from the visitors' side of the reception desk, for example. Any speech that officers can overhear unassisted while in a public area is also considered to be in "plain view"—even if it comes from a private

\*Texas and Florida currently require hospitals to ask patients about their immigration status so they can report to the state the aggregate amount of uncompensated care provided to undocumented patients. In both states, hospitals must inform patients that no matter how they respond to immigration-related questions, they will receive care. Providers' obligation to provide care under EMTALA is not affected by a patient's decision not to provide their status.
